Major Waldron Sportsmen's Association Refund Policy

Membership Renewal Payment:

In order to receive a refund for membership renewal in the Major Waldron Sportsmen's Association, a request for refund must be received in writing, within 30 days of the original membership renewal request, from the person paying for the membership with a postal mailing address to send the refund to. The date used to mark the membership renewal mailed in request will be the U.S. Post Office date stamp on the postal mail. The request for refund may be sent to the Major Waldron Sportsmen's Association by either e-mail or postal mail. Requests for refunds by phone will not be honored. The date used for marking the reception of the refund request as valid, will be the U.S. Post Office date stamp on the postal mail.

No refund will be issued after the member receives their new membership card.

No refund will be issued until the original payment has cleared the bank for checks.

The refund will come in the form of a check. The Major Waldron Sportsmen's Association will make every effort to send out the refund within four working weeks after receipt of the refund request.

New Membership Payment:

In order to receive a refund for new membership in Major Waldron Sportsmen's Association, a request for refund must be received in writing at least 30 days, from the date of the member's acceptance by the Board of Directors from the person paying for the membership, with a postal mailing address to send the refund to. The request for refund may be sent to the Major Waldron Sportsmen's Association by either e-mail or postal mail. Requests for refunds by phone will not be honored. The date used for marking the reception of the refund request as valid, will be the Major Waldron Sportsmen's Association e-mail service in box or the U.S. Post Office date stamp on the postal mail.
